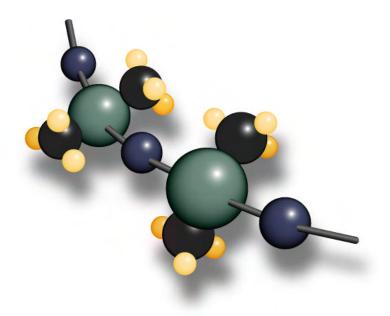

Instructions for Use

Add CAT-55 incrementally to a blend of VersaSil Series base stock and CAT-40 masterbatch. Adding CAT-55 to uninhibited VersaSil base material may lead to premature vulcanization. Direct contact of CAT-55 with CAT-40 inhibitor masterbatch results in severe discoloration. Meticulously clean spatulas and other material handling equipment between exposures of CAT-55 and CAT-40.

Storage

CAT-55 is supplied sealed in polypropylene bags and placed in HDPE containers. Store unused portions of CAT-55 by first re-wrapping material in the polypropylene bags and then sealing tightly in the polyethylene container.
